For Veterans, we have now added designation as a "Veteran," their period/theater of service, as well as branch of the military in which they served. Cemetery Introduces Summer Interment Hours

As temperatures rise and we enter summer months, changes are being made to the Coachella Valley Public Cemetery's service times to ensure the best possible climate. Beginning the week of May 14, 2023, a new summer graveside schedule was implemented.

This adjustment provides families with the opportunity to benefit from cooler morning temperatures, ensuring a more comfortable environment during services. Additionally, the maintenance crew will be able to navigate the grounds

more effectively while complying with Cal/ OSHA's Heat Illness Prevention Guidelines.

The revised schedule offers the following service times: Mondays, Wednesdays and Fridays: 8:30 a.m., 10 a.m., and 11:30 a.m. Tuesdays and Thursdays: 10 a.m. and 11:30 a.m.





New Section of Cemetery Now Available

On May 8, 2023, the District officially broke ground in Section 26 with our first scheduled interment. This section became available to the public on May 1 for pre-need and at-need purchases. The new section added approximately 700 lots to cemetery inventory.

Landscape Enhancements Improve Cemetery Grounds

The District successfully accomplished another milestone in its ongoing 2022/2023 Capital Improvement Project, "Landscape Improvement." The first phase involved the restoration of the islands situated in the median divides at the center of the cemetery. The District also added nearly 100 new trees as part of a concurrent project.

The most recent phase of the project concentrated on enhancing the front portion of the cemetery, specifically the north entrance. The main objective was to address deterioration caused by sand drift over time, resulting in a dirt basin. To rectify this, new rock features and shrubbery were reintroduced in the small curb section directly in front of the cemetery.



Looking ahead, the District is preparing for the final phase of the project, which will involve refreshing the area located in front of the cemetery on the south side of the wall. This upcoming phase will encompass various improvements, including the addition of more rocks to the existing beds and the replacement of wood chips with matching rocks in certain shoulder areas.

With each completed phase, the District is making remarkable progress in its comprehensive Capital Improvement Project, ensuring that the cemetery's landscape is restored and maintained to a high standard. These efforts demonstrate the District's commitment to providing a visually appealing and well-maintained environment for visitors and honoring the memories of those laid to rest.
