COACHELLA VALLEY PUBLIC CEMETERY DISTRICT REQUEST FOR INFORMAL QUOTE ROUTINE VEHICLE MAINTENANCE SERVICES

I. **GENERAL**

The Coachella Valley Public Cemetery District ("District") is requesting quotes ("RFQ") for mobile (on-site) routine service to be performed on our Maintenance vehicles.

II. SCOPE OF SERVICES; PROFESSIONAL SERVICES AGREEMENT

Regular routine service includes, but are not limited to:

- Oil and filter
- Air filter
- Cooling system
- Transmission
- Brakes
- Front/Rear Differential
- Hydraulic Components

Not all services listed above will apply to all vehicles listed. Other components identified as requiring routine service by a professional mechanic and in accordance with the vehicle service manual/manufacture specifications may also be requested as needed.

The vehicles that require service are described in Exhibit A (attached).

The District reserves the right to seek job details for each service ahead of performance of duties, including time estimate, date and time of service call, and other details related to the service being requested. The District reserves the right to get additional quotes for any single service if we believe more affordable services are available to us, or if the job is time sensitive and a vendor is unable to meet our request for appointment.

Submitted quotes may be utilized for up to two (2) years unless otherwise indicated, so please indicate if the quotes submitted are for a lesser time frame.

III. SUBMITTING QUOTE

Based on the vehicles and equipment listed in Exhibit A, those submitting to this quote should list their hourly service charge(s) for all services listed in Section II. If the hourly service rate varies based on equipment, please specify that in your quote. A sample quote submission is attached as Exhibit B.

The District reserves the right to purchase all equipment and supplies associated with the

described services, therefore we are seeking "labor rates" only.

We recommend proposers include information about their company and references as the District reserves the right to award project to the company best equipped to perform the work within budget.

All quotes submitted in person should be in clearly marked envelope as follows:

Quotes may be submitted by mail, but quotes received after the deadline will not be accepted regardless of postage date.

SAMPLE QUOTE SHEET

This Sample Quote Sheet is provided as an example only. The quote sheet you submit does not need to conform to this format but should offer the same information.

On-Site Heavy-Duty Equipment Service (Backhoes and Tractors): \$XX per hour

On-Site Light-Duty Equipment Service (Trucks, Side-by-Sides): \$XX per hour

Hourly service quotes are good for a period of two (2) years, until July of 2026.

This is only an example. You may supply a standard hourly rate, an hourly rate for each piece of equipment, a flat rate for each type of service, or whatever rate system best reflects your service pricing options. In order to achieve a relative comparison, the District reserves the right to reach out to each vendor for additional details, based on the quotes received.
