# **Cemetery Transforms for Annual Día de Los Muertos Celebration**

The Coachella Valley Public Cemetery will host a spirited celebration of Mexican culture that is expected to welcome more than 10,000 visitors with its annual festivities on **November 2, 2024**, **from 11:00 a.m. to 8:00 p.m.** This free event is open to all and offers the community a unique opportunity to honor their loved ones who have passed.



Families and friends are invited to gather together, honor their loved ones and create stunning altars decorated with colorful papel picado, marigolds, and photographs. Live music and dance performances will bring the cemetery to life, with music and Folklórico dancers showcasing the rich heritage of Mexico.

While most of the activities and festivities occur on November 2, the Coachella Valley Public Cemetery will also be open the day prior, on November 1, until 7:00 p.m. in observance of the holiday. Gates open to the public on both the 1st and the 2nd at 7:00 a.m.

Please note the cemetery will have parking and traffic restrictions in place on both days. Guests will not be allowed to park on the grounds, and will instead need to park in the back lot adjacent to the cemetery. Due to the amount of traffic expected, there is also no parking or stopping along Avenue 52 during these dates. The District thanks you in advance for your understanding.

There will be plenty for guests to experience during this event, including a traditional Honor Guard salute, remarks by elected officials, a benediction, and singing of the National Anthem. Seating and shade will be provided to all guests in attendance.

Veterans Day is a federal holiday in the United States observed annually on November 11 to mark the anniversary of the end of World War I and to honor and celebrate the service of all military veterans of the United States Armed Forces. # District's Budget Book Now Available Digitally

CVPCD's 2024 Budget Book is now available in a convenient digital format and is available as a free download on the District's website. A hard copy of the book is also available at the District's front office.

The 2024/2025 Fiscal Year budget is based on total revenues of more than \$4.5 million and total operating expenditures of \$3.6 million. The District's capital expenses for the year total \$1.5 million, with the combined total expense for the year being \$5.1 million.

The District possesses a Capital Expense reserve fund of over \$1,000,000 to help address deferred capital expenses, primarily covering necessary road repairs. This reserve fund will sufficiently cover additional projected capital



expenditures where required. Additionally, staff continues to pursue alternative revenue options to assist with financing our capital expenditures, including supplemental state and federal funding for our road construction project.

A complete copy of the budget, along with other important financial information, is contained in detail within the book. The District is proud to present this critical information to its constituents as part of its ongoing commitment to transparency and sound governance.
